Government sets up new laws and standards. Medical : MHLW (ministry of Health Labor and Welfare) Some proxies are designated for research and settlement of new standards. (mainly technical standards) one of them : HELICS (Health Information and Communication Standards Board)

When HELICS has authorized a standard, it is recommended to be included in RFP from public and private hospitals such as a new CT purchase.


