Pathology domain

- DICOM Image guideline Ver.2.0 : Done
 - The description of WSI (Whole Slide Imaging) is added.
 - The English version is also available.
- Sample Image data of WSI : Done
 - The sample image file will be uploaded to WG26 ftp site pretty soon.
 - It was created by DICOM standard documents, but is not verified yet. Because there is no viewer for that now.



4) JAHIS Standardization (cont.)

- Endoscopy domain
 - DICOM Image guideline Ver.1.0 : Working
 - Target completion : the end of this year
 - Color management : Working with WG13
 - The idea of "Color Space" has been accepted in the WG13 on May
 - DICOM has "Color Profile" specification now
 - Our proposal is to add "Color Space"
 - Working on how to set the information of the color space for the next WG13.
